1. Chairman's Welcome

After welcoming those present, Robin reflected on the past year and gave an update on the various exchanges that had taken place including School Student & Teacher exchanges, Golf Exchange, Culinary Exchange and Professional Exchange. Robin also spoke about the successful internship and gave an update on Eva's time in Grapevine and working for Visit West Lothian.

2. Approval of AGM Minute from 2011

The minute was proposed as an acceptable minute by Tom Kerr and seconded by John Aitken.

3. Matters Arising

John brought up the fact that we had once again had to bid for funding and although we had asked for £9,000 due to the forthcoming official visit and the various exchange visit's that the association were supporting, we only received £1,500.

At the last AGM John had presented unaudited accounts - these have now been examined by Robert Preston.

4. Treasurer's Report

John presented the meeting with the Accounts for the past year which have been issued but not yet independently audited. The current balance is just over £9,000. Accounts were approved subject to being audited. John noted that we had received £3,000 in funding from the Council last year but had spent around £6,000. He again raised his concerns about the apportionment of funding that we had received this year and does not understand why we were granted such a small amount, it seemed that we were being penalised for being prudent. Robin said that he had spoken to Gordon Connolly and he confirmed that we received a smaller amount because of the reserves we had in the bank.

Tom Kerr noted that Hochsaureland received a sizable portion of the funding due to the official visit to West Lothian taking place this year, however, he was more concerned that the Bathgate Twinning was becoming an official West Lothian Council Twinning organisation.
